'new types of danish alternative investment funds

May 25th, 2020 - in practice investment firms or alternative investment fund managers may use an aif sicav fund or an aif securities fund divided into sub partments each representing an asset class to be offered to investors e g shares bond real property and alternatives as a joint investment vehicle through which each individual investor can be offered investment exposure tailored to the varying"cyprus alternative investment funds overview of the May 19th, 2020 - the cyprus securities and exchange mission cysec is the regulatory authority responsible under the aif law for the licensing and supervision of alternative investment funds in cyprus'

June 2nd, 2020 - loan funds europe s alternative source of business funding at a european level the european long term investment fund elitif is being established while ireland has recently launched its own loan originating qualified investor alternative investment fund referred to below as irish loan fund ilf both"alternative investment fund aif fma österreich June 1st, 2020 - this was transposed into national law by the alternative investment fund managers act which entered effect on 22 07 2013 the term aif encompasses every collective investment

undertaking including its subfunds that collects capital from a number of investors in order to invest it in accordance with a determined investment strategy for the benefit of the investors'

June 3rd, 2020 - in the past alternative investment funds were generally created under part ii of the luxembourg law on investment funds then in 2007 a new law created the specialised investment fund sif which provided an additional vehicle specifically designed for qualified international investors'

'aifmd fca

June 8th, 2020 - its scope is broad and with a few exceptions covers the management administration and marketing of alternative investment funds aifs its focus is on regulating the aifm rather than the aif an aif is a collective investment undertaking that is not subject to the ucits regime and includes hedge funds private equity funds retail investment funds investment panies and real estate'

June 7th, 2020 - the principle pieces of legislation governing funds in jersey is the collective investment funds jersey law 1988 cif law for public funds and the control of borrowing jersey order 1958 cobo for private funds and their related codes of practice and guides issued by the jersey financial services mission the jfsc'
