April 7th, 2020 - it is clear from the court s case law that the expression place where the harmful event occurred or may occur in article 5 3 of regulation no 44 2001 is intended to cover both the place where the damage occurred and the place of the event giving rise to it so that the defendant may be sued at the option of the applicant in the "*copyrightability of characters*

May 11th, 2020 - characters can be differentiated into two categories graphic characters and fictional characters it is necessary to differentiate them and deal with them separately because the courts have themselves granted different levels of protection by laying down different tests to determine whether a character can be granted copyright protection'

May 11th, 2020 - proposals have been advanced for identifying fictional characters as copyrightable works in themselves under the bill as is equally true in the case of detailed presentations of plot setting or dramatic action we believe it would be unnecessary and misleading to specify fictional characters as a separate class of copyrightable works'

May 22nd, 2020 - the existing eu copyright rules dating back to the early 2000s allow member states to introduce copyright exceptions in these areas without obliging them to do so the new directive will bring the eu framework on exceptions up to speed with digital uses in certain areas like education research and cultural heritage'

May 30th, 2020 - a copyright notice or copyright symbol is an identifier placed on copies of the work to inform the world of copyright ownership while the use of a copyright notice was once required as a condition of copyright protection it is now optional'

May 27th, 2020 - this helps publishers better municate their copyright terms to merical and public sector users as will any other copyright notices on site if the copyright icon is not visible create an internal policy which summarises best practice and shows all employees how to utilise copyright protected materials greatly reducing the risk of infringement'
